Payment options:

Option #1: A payment in full of a ONE YEAR (12 month) COMMITMENT in the amount of \$ _____ is agreed upon by the corporate membership. The corporate membership will receive a 5% discount in the amount of \$ _____ to be paid in full immediately upon signing this agreement.

Option #2: A monthly charge on credit card of \$ _____ per month.

The Broadlands Golf Course will bill monthly fees by credit card on the 1st of each month. Billing is by credit card only. No checks or invoicing for membership. If I choose the monthly payment option, I will notify the Broadlands Golf Course if such credit card number and expiration date changes in a timely manner prior to any billing date or be subject to suspension of my membership and playing privileges until information is corrected and billing approved. **All seasonal memberships expire on the last day of the respective billing month.**

If, I am unable to complete my membership agreement, I must send written notification to terminate by membership no later than 30 days prior to the next billing month. **An early termination fee of \$200 will apply to all Membership cancelled before the initial term date.** Management will give every consideration in allowing termination if paying monthly. No refunds allowed for full payments.
