2018 Corporate Membership Agreement

Corporate Membership includes one foursome per day, unlimited use of practice facility, Cart Fee, 7- day advanced tee times (subject to availability), and 10% discount on all merchandise.

Terms:

1. The Corporate Membership is valid from the date this Agreement is signed to the last day of the month in which the member informs the golf course that they would like to terminate the membership.
2. The start of the membership will be pro-rated from the date the Agreement is signed to the last day of the month. Your first month of membership will begin on the 1st day of the 1st full month dues are collected.
3. Each Corporate Memberships will be allowed to designate up to 3 people with full membership privileges.
4. For monthly memberships the Primary Member must inform the golf course 14 days before they wish to terminate the membership after the initial 5-month commitment is complete. The membership will expire on the last day of the respective billing month.
5. A \$20 Prime Time Fee will be charged per member/guest for any tee times on Saturday or Sunday before noon including Men’s Club events. During Men’s Club events, no guests are allowed to play under the Corporate Membership.
6. The membership is not transferable to other players and the resale of tee times is strictly prohibited and will result in immediate termination of membership.
7. One of the three designated Corporate Members must play in the daily tee time. All players, including guests must check in at the Pro Shop before play.
8. One of three named members must make the tee time, no other people will be authorized to make times.
9. An individual corporate member guest can play 4 times per month at no charge, after the 4th round the member guest will be charged the \$20 Prime Time Fee.
10. The Broadlands reserves the right to adjust the pricing structure at the beginning of each golf season.

Payment options:

Option 1: A payment in full for a ONE YEAR (12 month) COMMITMENT will receive a 5% discount on the total cost of the membership if the agreed amount is paid in full immediately upon signing this agreement.

Option #2: The Broadlands Golf Course will bill monthly fees by automatic withdraw on the 1st of each month. Billing is by automatic withdraw only and must be paid in full each month by the Primary Member. If the Primary Member chooses the monthly payment option, they will notify the Broadlands Golf Course of any bank account changes in a timely manner prior to any billing date, or be subject to suspension of the membership and playing privileges until information is corrected and billing approved.

Early Termination:

If the Corporation is unable to complete the membership agreement, The Primary Member must send written notification to terminate the membership no later than 14 days prior to the next billing month. **An early termination fee of \$900 for a 12 month membership or termination before the 5 month minimum commitment for monthly membership will apply to all Memberships cancelled before the initial term date.** No refunds allowed for full payments.
